

São Paulo, October 14, - TOTVS S.A. (BOVESPA: TOTS3), the absolute leader in the sale of integrated enterprise management software in Brazil and the largest company in Latin America for small and medium business (SMB) segment, announces the acquisition of one of Datasul's major Distribution Franchises (FDIS). Hery Software Ltda. ("Hery") operates in Rio de Janeiro, Brazil Middle West and in both São Paulo and its countryside, with estimated annual revenue of R\$17.0 million.

Hery acquisition is in line with the Company's strategy of running its own operations in the country's most important regions and is part of the consolidation of the distribution channels, which began in 2007 last quarter. The acquisition price amounts to a maximum of R\$12,000,000.

In the first phase, the process aimed at consolidating Logocenter, Microsiga and RM channels into TOTVS franchises. The strong motivation within the company and in the channels involved helped conduct this complex process swiftly, which translated into positive results by the end of 2008 when practically all Company's sales came from the consolidated TOTVS channels.

Considering the low penetration of TOTVS' target market - the SMB segment - the consolidation process enables the Company to strengthen its distribution channels and tends to positively influence company sales generation.
